ORDER

The Inspection Committee constituted vide the U.O. read (2), have submitted their report recommending for extension of Provisional Recognition of the College for the Academic Year 2010-11 and also recommending the additional course of B.Tech. in Civil Engineering. The AICTE, vide their letter read (3) have given their approval to continue to conduct the following courses/programmes in the college. The Principal of the College has remitted the recognition fee due for the year vide the Cochin University Fund receipt read (1).

The Syndicate of the University, at its meeting held on 31.08.2010, vide item No.561.41, considered the report, resolved to approve the report and sanction extension of Provisional Recognition of the College of Engineering, Kidangoor, Kidangoor South P.O., Kottayam – 686 583 for the Academic Year 2010-11 and also to ratify the action of the Vice-Chancellor in sanctioning the additional course of B.Tech. in Civil Engineering in the College from the Academic Year 2010-11.

- 5. The recognised institution should obtain renewal of recognition at the start of each academic year, after fulfilling all necessary preconditions therefore.
- 6. The Recognised Institution should rectify the defects, if any, pointed out by the Inspection Committee before seeking further extension.
- 7. Conduct of examinations and award of degrees will be done by the University.
- 8. The recognised institution should pay annual recognition fee as well as other fees as stipulated by the University from time to time.
- 9. The University reserves the right to visit the institutions at any time to satisfy itself of the compliance of the terms and conditions.
- 10. The college should take immediate steps to rectify defects/shorts comings pointed out by the Inspection Committee of the University, if any. (For this purpose a copy of the Inspection Report for the current year is attached herewith)
- 11. Non-fulfilment of any condition will lead to withdrawal of recognition/non renewal of recognition.
