- 7. The Recognized Institution should rectify the defects, if any, pointed out by the Inspection Committee before seeking further extension.
- 8. Conduct of examinations and award of degrees will be done by the University.
- 9. The recognized institution should pay annual recognition fee as well as other fees as stipulated by the University from time to time
- 10. The University reserves the right to visit the institutions at any time to satisfy itself of the compliance of the terms and conditions
- 11. The shortage of faculty at higher levels may be filled up before the visit of the next Inspection Committee
- 12. The college should take immediate steps to rectify defects/short comings pointed out by the Inspection Committee. (For this purpose a copy of the Inspection Report for the current year is attached herewith)
- 13. Non-fulfilment of any condition will lead to withdrawal of recognition/non-renewal of recognition.
